## NOTIFICATION OF THE POSTPONED FORTY-THIRD ANNUAL GENERAL MEETING OF GENTING PLANTATIONS BERHAD TO BE HELD ON TUESDAY, 21 SEPTEMBER 2021 AT 10.00 A.M.

Dear Shareholders.

Genting Plantations Berhad ("the Company") refers to the announcements made to Bursa Malaysia Securities Berhad on 6 April 2021, 31 May 2021 and 10 June 2021 in relation to the Forty-Third Annual General Meeting of the Company originally scheduled on 1 June 2021 at 10.00 a.m..

The Company wishes to inform that its Postponed Forty-Third Annual General Meeting ("Postponed 43rd AGM") will be held on a virtual basis through live streaming and online remote voting ("RPV") at the Broadcast Venue, 25th Floor, Wisma Genting, Jalan Sultan Ismail, 50250 Kuala Lumpur, Malaysia via TIIH Online website at <a href="https://tiih.online">https://tiih.online</a> on Tuesday, 21 September 2021 at 10.00 a.m..

The agenda of the meeting as stated in the Notice of the 43rd AGM issued on 6 April 2021 shall remain unchanged except for the proposed Ordinary Resolution 1 that has been withdrawn. This is because the proposed Ordinary Resolution 1 was in respect of the proposed payment of a final single-tier dividend of 4.0 sen per ordinary share for the financial year ended 31 December 2020 which had since been reclassified as a second interim single-tier dividend of 4.0 sen per ordinary share and paid on 22 June 2021. As such, the proposed **Ordinary Resolution 1 is redundant**.

## IMPORTANT NOTES

- The Proxy Form for Postponed 43rd AGM DOES NOT INVALIDATE the proxy form which was circulated together with the Notice of 43rd AGM dated 6 April 2021 ("Original Proxy Form"). All Original Proxy Forms deposited with Tricor not less than forty-eight (48) hours before the time appointed for holding the meeting or any adjournment thereof shall remain valid and acceptable.
- Subject to the appointer being a member who is entitled to attend the Postponed 43rd AGM, the Original Proxy Form that has be en deposited with Tricor shall remain valid unless a Proxy Form for Postponed 43rd AGM superseding the previous deposited Original Proxy Form (if any) is deposited with Tricor.
- For the purpose of determining members who shall be entitled to attend the Postponed 43rd AGM, the Company shall be requesting Bursa Malaysia Depository Sdn Bhd to issue a Record of Depositors as at 10 September 2021. Only depositors whose names appear on the Record of Depositors as at 10 September 2021 shall be entitled to attend the said meeting or appoint proxies to attend and vote on their behalf. For the avoidance of doubt, the Original Proxy Form received from any member whose name is not on the Record of Depositors as at 10 September 2021 shall be deemed null and void.
